Is zucchini a fruit or vegetable?

Is cucumber and tomato a fruit?

To a botanist, a fruit is an entity that develops from the fertilized ovary of a flower. This means that tomatoes, squash, pumpkins, cucumbers, peppers, eggplants, corn kernels, and bean and pea pods are all fruits; so are apples, pears, peaches, apricots, melons and mangos.

Is courgette a fruit or vegetable?

Something like a pea for example, whilst technically a fruit, is eaten as a vegetable. The same can be said for courgettes and squashes. "The simplest way to identify which is a fruit and which is a vegetable is that fruit has seeds. So in a cucumber the seeds run through the middle of the plant.

What makes a fruit or vegetable?

Botanically, fruits and vegetables are classified depending on which part of the plant they come from. A fruit develops from the flower of a plant, while the other parts of the plant are categorized as vegetables. Fruits contain seeds, while vegetables can consist of roots, stems and leaves.

Why is a tomato not a vegetable?

Tomatoes are botanically defined as fruits because they form from a flower and contain seeds. Still, they're most often utilized like a vegetable in cooking. In fact, the US Supreme Court ruled in 1893 that the tomato should be classified as a vegetable on the basis of its culinary applications.

Which president has nominated the most justices?

George Washington holds the record for most Supreme Court nominations, with 14 nominations (12 of which were confirmed). Making the second-most nominations were Franklin D. Roosevelt and John Tyler, with nine each (all nine of Roosevelt's were confirmed, while only one of Tyler's was).

How many federal judges did Ronald Reagan appoint?

In total Reagan appointed: four justices to the Supreme Court of the United States, including the appointment of a sitting associate justice as chief justice, 83 judges to the United States Courts of Appeals, 290 judges to the United States District Courts and 6 judges to the United States Court of International Trade.

Are all federal judges appointed?

Who appoints federal judges? Supreme Court justices, court of appeals judges, and district court judges are nominated by the President and confirmed by the United States Senate, as stated in the Constitution.

How many federal judges did George Washington appoint?

President George Washington appointed 9 justices to the Supreme Court and 28 judges to United States district courts.

What does OCA mean in legal terms?

The Office of Court Administration (OCA) is a unique state agency in the Judicial Branch that operates under the direction and supervision of the Supreme Court of Texas and the Chief Justice.

How does the Third Amendment apply today?

The Third Amendment seems to have no direct constitutional relevance at present; indeed, not only is it the least litigated amendment in the Bill of Rights, but the Supreme Court has never decided a case on the basis of it.

Who must approve the choices for the president's cabinet?

The United States Constitution provides that the president "shall nominate, and by and with the Advice and Consent of the Senate, shall appoint Ambassadors, other public Ministers and Consuls, Judges of the Supreme Court, and all other Officers of the United States, whose Appointments are not herein otherwise provided ...
