When there is an alleged violation to Hipaa?

If you believe that a HIPAA-covered entity or its business associate violated your (or someone else's) health information privacy rights or committed another violation of the Privacy, Security, or Breach Notification Rules, you may file a complaint with the Office for Civil Rights (OCR).

Is defined under Hipaa as the release of information containing PHI outside of the covered entity CE?

HIPAA provides individuals with the right to request an accounting of disclosures of their PHI. ... "Use" is defined under HIPAA as the release of information containing PHI outside of the covered entity (CE).

What is a disclosure under Hipaa?

Disclosure means the release, transfer, provision of access to, or divulging in any manner of information outside the entity holding the information.
