Which is correct got or gotten?

In American English, "got" and "gotten" can both be past participles of the verb "get." The correct term depends on what you are describing: Use got when referring to a state of possessing something. Use gotten when referring to a process of "getting" something.

Got vs. Gotten - What's the Difference?

Is it got or gotten? Got is a conjugation of the verb get, which means to obtain something. Then, on Dec. 5, the regime of Xi Jinping got something at least as valuable from Daines. – The Washington Post

Have Got or Have Gotten?

Got works in all cases, with the exception of archaic expressions like ill-gotten gain. It's a bit more complicated in the U.S. When we use get in the primary sense of "obtain or gain possession of" and in several other uses, it's more common to use gotten in the perfect cases.

Which is correct everything is or everything are?

'Everything is' is correct because 'thing' is singular so it has the singular form of the verb 'to be ' which is 'is'. 'Are' is plural and cannot be used for thing.

Which is correct each is or each are?

2 Answers. When you say "each of them", you're referring to each individual in a group (them), so you should use a singular verb. That leaves two possibilities: Each of them is used for different purposes.

Which is correct each of you has or each of you have?

Each in "Each of us has a laptop" is like every one, as in "Every one of us has a laptop." Therefore, the verb is singular. Each in "We each have a laptop" is like all, as in "We all have a laptop." Therefore, the verb is plural.

Which is correct it is she or it is her?

"This is she" is grammatically correct. The verb "to be" acts as a linking verb, equating subject and object. So this is she and she is this; "she" and "this" are one and the same, interchangeable, and to be truly interchangeable they must both play the same grammatical role—that of the subject.

Which is correct into or in to?

The word "into" is a preposition that expresses movement of something toward or into something else. ... "In to," on the other hand, is the adverb "in" followed by the preposition "to." They aren't really related and only happen to fall next to each other based on sentence construction.

Which is correct he has or he have?

Have is the root VERB and is generally used alongside the PRONOUNS I / You / We / Ye and They and PLURAL NOUNS. Generally, have is a PRESENT TENSE word. Has is used alongside the PRONOUNS He / She / It and Who and SINGULAR NOUNS.

Which is correct it's or its?

It's is a contraction of "it is" or "it has." Its is a possessive determiner we use to say that something belongs to or refers to something. It's and its are among the most commonly confused words.

Which is correct on to or onto?

Onto is a preposition, it implies movement, and is more specific that on. On to are two words, and when paired with each other, on acts as a part of a verbal phrase and to acts as a preposition.

Which is correct this is he or this is him?

The easiest way to remember which one to choose is to just remember, "Is" is acting as a linking verb. Linking verbs cannot take objects. "Her" is an object, so it must be "she."

Which is correct it is he or it is him?

Unless you're a speaker of British English or have been bingewatching "Sherlock." 
